<p>Benchmarks for St. Catherine tests(for information they must know) were lowered; students are scoring closer to the benchmark.</p> <p>We will begin to acquire the same data using our own Twelve week finals by the 2022 assessment plan. Specific test questions will be utilized for evaluating the understanding of methods of transmission, anode heel effect, etc. Changes in assessment plan will be seen in the 2022 assessment plan; otherwise overall assessment plan approved and carried over.</p> <p>SLO #3- secondary tool for radiation protection needed for assessment. Badge reporting has consistently stayed at a 100% return, no more assessment/evaluation necessary. Floor opened for discussion. PD suggested using rad protection quiz that is offered at the beginning of program in Intro to rad as a possible tool.
