It has been a little over a year since we migrated to the new Ascension-wide IRB system. For the most part, the process has gone well and everyone has done a great job at adapting to the new mode of conducting business with the IRB.

A few reminders about the new IRB process.

- We no longer use IRBNet; this program has been replaced by eIRB. https:// eirb.ascension.org You need to register in eIRB (if you are new to the system), using your Ascension email address.
- You need to have your CITI training (less than three years old) on file in the CITI program, under the Ascension affiliation. If you did your CITI training elsewhere, you can add an Ascension affiliation in CITI and the courses you took should "roll over" and appear under Ascension. We no longer send the CITI certificates to the IRB; they look them up directly. You need to take the basic course in human subjects protections in the role of investigator.
- Every investigator on a project needs to have an Investigator Agreement and their CV on file with the Research Integrity office. The form and your CV should be emailed to researchintegrity@ascension.org.

Consent for Case Reports

It is required that you obtain consent from patients or next-of-kin when you plan to write a case report. We have a standard consent form that should be used. The consent needs to be in writing, a verbal consent is not sufficient. Please remember to both sign and date the consent form as the requesting author. Please contact Dr. Szpunar for a copy of the consent form and instructions, if needed.

Remember that none of the 18 elements of PHI should ever be included in a case report. The 18 elements are:

- 1. Patient names
- 2. Geographical elements
- 3. Dates related to the health or identity of individuals
- 4. Telephone numbers
- 5. Fax numbers
- 6. Email addresses
- 7. Social security numbers
- 8. Medical record numbers
- 9. Health insurance beneficiary numbers
- 10. Account numbers
- 11. Certificate/license numbers
- 12. Vehicle identifiers
- 13. Device attributes or serial numbers
- 14. Digital identifiers, such as website URLs
- 15. IP addresses
